

## RESOLUTION NO. 2007-16

**A RESOLUTION TO PERMIT THE APPOINTMENT OF SPECIAL REGISTRATION DEPUTIES TO FACILITATE VOTER REGISTRATION AND ELECTIONS**

**WHEREAS**, Wis. Stat. § 6.55(6) provides that the governing body of any municipality may provide by resolution that any of the registration duties of inspectors under Wis. Stat. § 6.55(2) shall be carried out in the municipality by special registration deputies appointed by the municipal clerk at any polling place or registration location whenever the clerk determines that the registration process provided for in that subsection will be facilitated thereby; and

**WHEREAS**, the Town Board wishes to grant such authority to the Town Clerk.

**NOW THEREFORE BE IT RESOLVED** by the Town Board of the Town of Vernon that:

1. Any of the registration duties of inspectors under Wis. Stat. § 6.55(2) shall be carried out in the Town of Vernon by special registration deputies appointed by the Town Clerk of the Town of Vernon at any polling place or other registration location whenever the Town Clerk determines that the registration process provided for in that subsection will be facilitated thereby;
2. A registration deputy appointed pursuant to this resolution and Wis. Stat. § 6.55(6) shall be appointed for one election only to conduct elector registration only;
3. Special registration deputies appointed pursuant to this resolution and Wis. Stat. § 6.55(6) shall meet the applicable qualifications set forth in Wis. Stat. § 7.30(2); and
4. The authority granted the Town Clerk pursuant to this resolution and Wis. Stat. § 6.55(6) shall not be construed to otherwise limit the Town Clerk's authority to appoint election workers under applicable Wisconsin Law.

**SECTION 2: SEVERABILITY.** The several sections of this resolution are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the resolution. The remainder of the resolution shall remain in full force and effect. Any other resolutions whose terms are in conflict with the provisions of this resolution are hereby repealed as to those terms that conflict.

**SECTION 3: EFFECTIVE DATE.** This resolution shall take effect immediately upon passage and posting or publication as provided by law.
