## Procedure for Obtaining a Operator's License

---

1. Fill out the application on the reverse side.
2. Have background check done at the Vernon Town Hall. The fee is \$10.00.
3. You will need to supply your driver's license and proof of completing the RESPONSIBLE BEVERAGE SERVICE CLASS. Call Waukesha County Technical College at 1-262-691-5566 to register for the RESPONSIBLE BEVERAGE SERVICE CLASS or take the class on-line at <http://www.serverlicense.com> or <http://www.learntoserve.com> .
4. When the above is completed, bring the following to the Vernon Town Hall:
  - a. Completed Application
  - b. Responsible Beverage Service Class Course completion Slip
  - c. \$55.00 (\$45. For license and \$10. For background check)
  - d. You will then be placed on the next Town Board agenda for review.
5. We will notify you when your regular two year license is ready to be picked up.
